Should Puppy develop any life threatening medical disorder, which is confirmed by two unassociated veterinarians, seller will, upon review of veterinary reports provide a replacement puppy of same quality, sex etc. as soon as such a puppy is available. Any life threatening disorder must happen within Six (6) months from the date of birth, buyer MUST return the DOG to SELLER for a replacement puppy. Conditional and limited guarantee.

Buyer will pay all shipping and miscellaneous charges associated with transport of both the puppy back to seller and the replacement puppy back to Buyer.

All shipping and transportation expenses are responsibility of the BUYER.

Seller shall not be held responsible for the development of disqualifying faults, diseases, viruses or disorders, which are due to Buyers negligence.

## HEALTH GUARANTEE

1. Seller guarantees that Puppy is in good health and has received appropriate medical inoculations, worming and care. Seller will provide Buyer with medical records detailing treatment Puppy has received under Seller's care, and any future care Seller feels is essential to Puppy's well being.
2. Seller guarantees that Puppy is free of life threatening diseases or disabilities to my knowledge at time of sell and transfer.
3. At no time will the Seller be responsible or obligated to pay for Veterinary Treatments not agreed upon IN ADVANCE.
4. This guarantee does not cover common ailments (such as kennel cough, giardia, coccidiosis, parasites, parvo, distemper and cherry eye).
